STATEMENT OF FAITH

- 1. We believe the Bible to be the inspired, the only infallible, authoritative Word of God.
- 2. We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit.
- 3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory.
- 4. We believe that for the salvation of lost and sinful man, regeneration by the Holy Spirit is absolutely essential, and that this salvation is received through faith in Jesus Christ as Savior and Lord and not as a result of good works.
- 5. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly life and to perform good works.
- 6. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation.
- 7. We believe in the spiritual unity of believers in our Lord Jesus Christ.

STATEMENT OF PRINCIPLE

- 1. Hope Pregnancy Center (HPC) is an outreach ministry of Jesus Christ through His church. Therefore, HPC, embodied in its volunteers, is committed to presenting the Gospel of our Lord to women with crisis pregnancies both in word and in deed. Commensurate with this purpose, those who labor as HPC board members, directors, and volunteers are expected to know Christ as their Savior and Lord.
- 2. HPC is committed to providing its clients with accurate and complete information about both prenatal development, and abortion.
- 3. HPC is committed to integrity in dealing with clients, earning their trust and providing promised information and services. HPC denounces any form of deception in its corporate advertising or individual conversations with its clients.
- 4. HPC is committed to assisting women to carry to term by providing emotional support and practical assistance. Through the provision of God's people and the community at large, women may face the future with hope and plan constructively for themselves and their babies; and
- 5. HPC does not discriminate in providing services because of race, creed, color, national origin, age, or marital status of its clients.
- 6. HPC does not recommend, provide, or refer for abortion or abortifacients.
- 7. HPC offers assistance free of charge at all times.
- 8. HPC is committed to creating awareness within the local community of the needs of pregnant women, and of the fact that abortion only compounds human need rather than resolving it.
- 9. HPC does not recommend, provide, or refer single women for contraceptives in the "clinical" sense. (Married women seeking contraceptive information are urged to seek counsel, along with their husbands, from their pastor and physician.)
- 10. HPC recognizes the validity of adoption as one alternative to abortion, but is not biased toward adoption when compared of other life-saving alternatives. Centers are independent of adoption agencies, relating to them in the same manner as to other helpful referral sources. HPC receives no payment of any kind from these agencies, does not enter into contractual relationships with them, and does not share combined office space. Adoption agencies are not established under the auspices of centers. HPC will neither initiate nor facilitate independent adoptions, though they may refer for independent adoptions in states where it is legal.



CODE OF CHRISTIAN CONDUCT

- We do not offer, recommend or refer for abortions or abortifacients, but we are committed to offering accurate information about abortion procedures and risks.
- We believe the Bible is the authoritative Word of God and provides guidance for our lives.
- We believe in chastity outside of marriage and fidelity within. We believe in the sanctity of marriage between one man and one woman as taught in the Bible. Therefore, all staff and volunteers commit to a lifestyle of sexual purity, and will refrain from engaging in any sexual relationships outside the bonds of Christian marriage.
- All Board members, staff, volunteers, and other representatives of HPC shall agree with HPC's Statement of Faith, profess Jesus Christ as Lord and Savior, hold a solid pro-life position on abortion and live a lifestyle consistent with biblical values.
- All "conflict of interest" relationships will be avoided with Board members, staff, suppliers, those we serve, and other organizations with whom we deal, unless disclosed and approved.
- No one will accept gifts or favors which might influence the performance of their responsibilities.
